Sub:- Provisional recognition of the school.

Sir,

With reference to your application dated 30.8.1967 on the subject cited above, I am to convey sanction for recognition of the Higher Secondary Deptt. of the above said school under the All-India Hr. Sec. Scheme of the Board for a period of two years w.e.f. 1.5.1968 to 30.4.1970 with permission to open class IX w.e.f. 1.5.1968 for the teaching of the following subjects:-

## (A) Core Subjects

- Hindi, Sanskrit, English
- General Science, Elementary Mathematics, Social Studies, Indian Culture & Civilization and Special Mathematics.
- Craft Subjects:- Wood Work, Metal Work, Gardening, Leather Work, Electric Gadgets and their repairs, Paper Craft and Paper Mache., Sewing: Needle Work & Embroidery, Pottery(Lacquer Work and Toy Making), Workshop Practice and Commercial Art.

(B) Elective Subjects Group I (Humanities), Sanskrit, English, English Language & Literature, History, Geography, Economics, Civics, Mathematics, Music-Vocal (Hindustani or Karmatak), Music-Instrumental, Drawing & Painting and Elements of House Decoration & Home Science.

Group II-(Science & Technology) Physics, Chemistry, Biology, Geography, Mathematics, Physiology & Hygiene, Elements of House Decoration and Home Science, Geometrical & Mechanical Drawing, Engineering Technology-(a) Workshop Practice, and (b) Any one of the following:- (i) Machine Shop, (ii) Electric Trade, (iii) Elements of Mechanical Engineering, (iv) Elements of Building Construction, (v) Elementary Radio Mechanic, (vi) Elementary Motor Mechanics.

Group VI-(Home Science) Household Management and Home Relationship, Textiles, Clothing & Laundry, Food, Nutrition & Cookery and Home Nursing, Child Development & Mothercraft.

Reading is not an approved Craft and as such recognition in the same cannot be granted.

This sanction is subject to the fulfilment of the following conditions laid down by the Inspection Committee, which visited your school on 24.10.1967:-

- Reserve Fund of Rs. 5,000/- more be created in the joint name of the Director of Education and the Manager of the school immediately.
- The proposed two additional large-size rooms be constructed immediately for laboratories etc.
- At least Rs. 4,000/- should be spent on each lab. for equipment apparatus according to the minimum requirements of the Board, close of the year 1968-69 and another sum of Rs. 2000/- each on the labs. in the following year.
- The library should be strengthened. At least Rs. 2000/- be spent on the purchase of library books during the academic year 1968-69 for higher sec. classes and another Rs. 1500/- be spent in the

following year. The books should be purchased as per the list of library books recommended by the Board. There should be a section in the library containing reference books for teachers.

5. A qualified Principal and qualified teachers in the subjects in which recognition is granted should be appointed in accordance with the minimum qualifications laid down by the Board. The management may apply to the Board for seeking exemption in the case of Mrs. S. to hold the post of Principal, if considered necessary.

6. The school should not introduce any additional subject without obtaining prior sanction of the Board. The recognition will stand withdrawn in such subjects in which teaching is not started during the academic session 1968-69; but the management may apply again for recognition in additional subjects whenever necessary.

7. The school should observe inter-school rules.

8. The school should observe the rules and regulations of the Board and comply with such instructions as may be issued by the Board from time to time.

9. *The school will not prepare candidates for any other exam.*
